
PLAN TO RESUME VISITATION

1. Mary Agnes Manor will only allow visitors 18 years or older. All visits are by appointment only, no walk-ins allowed.
2. Mary Agnes Manor staff member will be present to monitor visitation, and to clean and disinfect visitation area after each visit.
3. Mary Agnes Manor will maintain signage regarding face mask utilization and hand hygiene practices.
4. Mary Agnes Manor currently utilizes applicable floor markings to cue social distancing delineations. Visitors must maintain a 6 feet distance from the resident at all times throughout the visit. No touching, hugging, or kissing is allowed.
5. All visitors are to be screened for signs and symptoms of COVID-19 prior to resident access. Any visitors exhibiting signs or symptoms of COVID-19 or those that do not complete and pass the screening questionnaire will be refused access to residents for visits.
6. Resident and visitors will be supplied mask for visitation purposes. Masks must cover both mouth and nose at all times.
7. All visits will be conducted in one of two activity rooms on the first floor.
8. Alcohol based hand sanitizer will be provided to resident and visitor.
9. There will be no more than two (2) visitors allowed per resident at one time.
10. Visitor fact sheet will be provided upon initial screening to all visitors.
11. Plan has been reviewed by the Administrator, Quality Assurance Manager, and the Case Manager.
12. Hours of visitation will be Monday through Friday 9AM to 5PM. Visitation will be suspended for a duration if staff or residents test positive for COVID 19.



VISITOR FACT SHEET

- ALL VISITORS MUST ENTER AT THE FRONT DOOR OF THE BUILDING FOR SCREENING PURPOSES!!
 - ALL VISITORS MUST COMPLETE AND PASS THE MANDATORY VISITOR QUESTIONNAIRE PRIOR TO THE VISIT!!
1. All visitors must be 18 years or older. Limited number of visitors must be no more than two (2) visitors per resident at any time. You must sign in and out.
 2. All visitors must pre-schedule visits with the Case Manager or the Receptionist. No walk-ins allowed.
 3. All visitors must be provided with this fact sheet pre-visit.
 4. All visitors must always wear a mask over their **mouth and nose** for the duration of the visit and sanitize your hands prior to visit. There can be no touching, hugging, or kissing during the visit. Failure to follow the rules will restrict you from further visitation during the COVID 19 Pandemic. No exceptions!
 5. If visitor exhibits any COVID-19 signs or does not pass screening questions, they will be refused access to visit.
 6. Visitors must maintain social distance, minimum of six (6) feet distance from resident.
